1. I understand that boarding charges begin when pet is checked in kennel during regular business hours. Pets checking out before 2:00 p.m. (with the exception of Sundays & Holidays) will not be charged for that day's board. Pets checking out after 2:00 p.m. will be charged a full day's board.

2. Sunnybrook Kennels, hereinafter referred to as the "kennel," agrees to exercise due care to keep its premises both sanitary and properly enclosed; however, the owner of said animal agrees to hold harmless the kennel from liability arising out of said animal jumping or climbing over fence enclosures and any self-inflicted injuries caused by said animal.

3. The kennel does not assume and will not be held responsible for any direct or consequential damages with respect to the above listed animal. The owner of said animal agrees to release and hold harmless the kennel from liability arising out of any cause including, but not limited to: damages from disease, injury to persons, animals and property caused by any animal boarded at the kennel. The owner of such animal fully agrees to be solely financially responsible for any behavioral acts of the animal to persons, kennel property or themselves. Furthermore, the owner warrants that the above named animal has not been exposed to distemper, rabies, or any other contagion within the last 30 days.

4. Should the animal become ill, the kennel, in its sole discretion, may engage the services of a veterinarian or administer medication, and the expenses thereof shall be paid by the owner.

5. As used within this document, the singular should be construed to mean plural where appropriate. Gender shall be neutral with masculine interchangeable with the feminine. Should any word, sentence, or section of this agreement come to be invalid, such determination shall not alter or affect any other, word, sentence, or section. The remedies to the kennel herein are cumulative and not alternative. There shall be no changes or waiver of any of the terms of this contract. The kennel will not be bound by any changes to this agreement be they written or oral. All the terms and conditions of this agreement shall be binding on the heirs, administrators and assigns of the owner of the above animal.

6. The owner or person(s) signature guarantees payment of this bill. Payment is due when services have been rendered. There will be 1.5% per month interest charge on all overdue bills or any portion thereof. Should the kennel resort to an attorney for collection purposes, the owner agrees to pay reasonable attorney's fees and other such costs as the court may allow.
